What is the purpose of this statement?

This statement provides key information about the Generate KiwiSaver Scheme Focused Growth Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The objective of the Focused Growth Fund is to provide a higher growth investment return for members over the medium to long term through investment in a portfolio of actively managed cash, property and infrastructure assets and international equities managers.

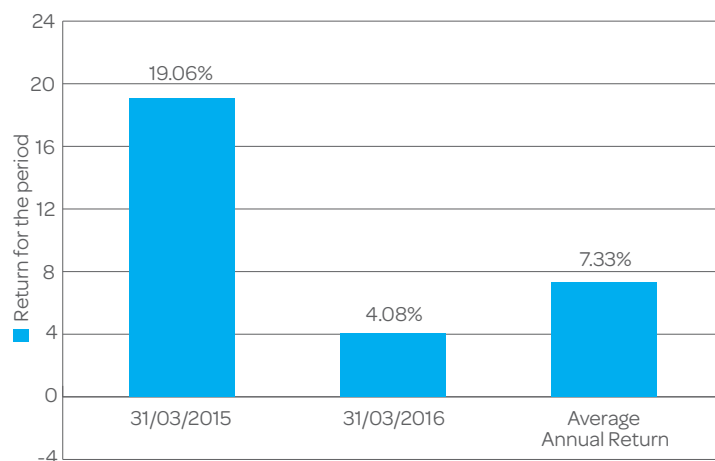

How has the fund performed?

How has the fund performed in the past?

This shows the return after fund fees and tax for each tax year since the fund started and the average annual return since the fund started. It's important to note that this doesn't tell you how the fund will perform in the future.



What fees were members charged?

The returns above are after deductions for fund fees.²

These fees were last totaled up for the year to 31 March 2016 and were:

Total fund fees	1.77% of members' investments
Annual management fee	0.95%
Performance-based fees	0.00%
Other fees and costs	0.82%

Members were also charged membership fees³ of \$36 over the year to 31 March 2016.

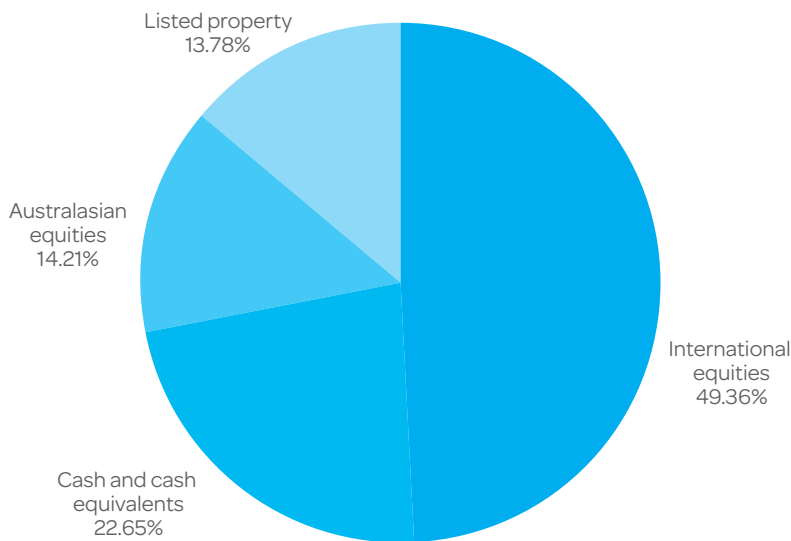
Example of how this applies to a member

Sarah had \$10,000 in the fund at the start of year and didn't make any further contributions. At the end of the year, Sarah received a return after fund fees and tax were deducted of -\$334 (that's -3.34% of her initial \$10,000). Sarah also paid \$36 in membership fees. This gives Sarah a total return of -\$370 for the year.

What does the fund invest in?

Actual investment mix

This shows the types of assets that the fund invests in. In the graph below 'Cash and cash equivalents' includes the value of foreign exchange hedging derivatives related to the fund's off-shore investments.
